You can apply for a grant under the Cooperative Energy Generation Grant Scheme (Subsidierегeling Coöperatieve Energieopwekking/(SCE). In some cases, you will need an integrated physical environment permit (omgevingsvergunning) to install the solar panels. You should therefore check your local authority's zoning plan before buying solar panels.

If you install a set of 10 rooftop solar panels on your commercial building, you will reduce your carbon emissions by 1,400 kilos.
