Who provides electricity in Georgia?

In Georgia, such supply is provided by JSC "EP Georgia Supply" (for customers connected to the network of JSC ENERGO-PRO Georgia) and LLC "Tbilisi Electricity Supply Company" (Telmiko) (for customers connected to the Telasi network). The public supply obligation is imposed on the supply companies by a decree of the Government of Georgia.
