What does the Gibraltar Electricity Authority do?

The Gibraltar Electricity Authority is responsible for the generation, distribution and supply of electricity to the civilian population of Gibraltar.

What if the supply of electricity is discontinued in Gibraltar?

Where the supply of Electricity has been discontinued under Section 19 of the Gibraltar Electricity Authority Act 2003, an Administration Fee of €35.50 shall be paid by the Customer before the Electricity Supply is restored. Tariffs, charges and prices for the supply of Electricity which apply as from August 2024.

Does Gibraltar have electricity?

Until recently, Gibraltar's electricity supply was dependent on some 40 diesel-powered engines and turbines distributed across Gibraltar. In 2019 a new, modern power station situated at the North Mole commenced operation running long term on liquid natural gas (LNG).

There are currently three installations in Gibraltar producing energy. Two of these installations namely Waterport and OESCO power stations supply electricity to the civil population,...

Why does Gibraltar need a new power plant?

This secures Gibraltar's energy supply economically, environmentally and sustainably. The associated closure of the three old plants represents the largest measure taken to improve air quality and reduce greenhouse gas emissions. The new power plant consists of six engines; 3 of which run on natural gas and 3 of which are dual fuel.

When did electric lighting start in Gibraltar?

On 15 September 1896, construction of the King's Bastion Power Station, based in the old King's Bastion, was started with the help of a loan raised under the Electric Light Ordinance of 1892. The first demonstration of electric lighting in Gibraltar was conducted in April 1897. The Electric Light department was established on 9 March 1898.
