The Heard Island and McDonald Islands (HIMI) Marine Reserve was declared as a Commonwealth reserve under the Environment Protection and Biodiversity Conservation Act 1999 (the EPBC Act) and assigned to the IUCN category 'strict nature reserve'.

Can battery storage be built in a few months?

To deliver this, battery storage deployment must continue to increase by an average of 25% per year to 2030, which will require action from policy makers and industry, taking advantage of the fact that battery storage can be built in a matter of months and in most locations.
