

# Latest policy on solar container subsidies in north asia

What new cross-border subsidies are coming from China to Thailand?

The Commerce investigation found three new cross-border subsidies, all from China into Thailand: the cross-border provision of Chinese wafers, solar glass, and silver paste. This is the first time the Commerce Department has calculated transnational subsidies in any countervailing duty investigation.

How can subsidies help a solar PV industry in Europe?

In Europe, supporting local solar PV manufacturing through subsidies or investment can improve competitiveness, create jobs, and increase self-reliance. Compared to trade barriers on China, subsidies can cut industry expenses by 23.6%, create jobs 27.5% more cost-efficiently, and provide a similar gain in self-sufficiency.

Are Thai solar producers benefiting from government subsidies?

"The increased duty rates demonstrate that Thai solar producers are benefiting not only from Thai Government subsidies, but also from discounted raw materials received from government-controlled entities in China," said Tim Brightbill, Partner at Wiley Law and lead attorney for the American Alliance for Solar Manufacturing Trade Committee.

Subsidies for producers are conducive to increasing the self-sufficiency in module production by shifting some costs from companies to the government.
