The solar industry in Myanmar has experienced a significant expansion of ten times its previous size within the last year. Solar panels are classified as priority products for import, alongside other commodities such as medical supplies and fuel.

The Ministry of Planning and Finance has exempted "solar and related components" from customs tariffs, according to a notification dated 20 April. Qualifying products include the following: Solar panels; Solar charge controllers; Solar powered inverters (string, combined battery, dual-use, main)

To have energy sufficiency, solar and related components are exempt from customs tariffs. Solar panels, solar charge controller, solar powered inverter (string, combined battery, dual-use, main), household solar inverter, (roof and on-ground installation), solar energy installation system (installation on water), solar controller and battery ...

According to Volza's Myanmar Import data, Myanmar imported 2 shipments of Solar Module during Jul 2021 to Jun 2022 (TTM). These imports were supplied by 2 foreign exporters to 2 Myanmar buyers, marking a growth rate of -33% compared to the preceding twelve months. Within this period, in Jun 2022 alone, Myanmar imported 0 Solar Module shipments.

As worsening power cuts push businesses to use solar energy, import and foreign currency restrictions and corruption in the customs department slow down growth in the off-grid sector, while the regime awards on-grid solar projects to their families and cronies.

Starting a Solar Panel import business in Myanmar requires adherence to many rules and regulations. The most crucial step is obtaining an Import Export Code (IEC) from the Directorate General of Foreign Trade (DGFT). Businesses must also comply with the Government of Myanmar's Foreign Trade Policy (FTP), which governs product imports.

In addition to exempting BEVs from SGT and CT, the UTL 2023 exempts certain goods related to solar modules and panels from CT. The MOPF also announced customs tariff exemptions for these same goods. The exempted goods include many types of photovoltaic panels, controllers, inverters, battery boxes, and other
